It is further agreed by the parties hereto that the lessee shall have the right to remove water pumps, piping, plumbing fixtures, lighting fixtures, heating plant and such other aparatus as he may place on the premises at his own expense, subject to the payment of any unpaid rents.

It is for ther agreed by the parties hereto that the lessor shall keep the roof, fundations and other structural flatures of the building in good repair at his own expense, and that the lessee shall have the right to make any changes in arrangement which he may wish to make at his own expenses.
