Township, Greenville County, State of South Carolina.

Known and designated as Lot No. 16 and the Eastern half of Lot No. 17 as shown by plat of Augusta Road Hills made by Dalton & Neves in December 1940, recorded in the R. M. C. Office for Greenville County in Plat Book "L", pages 56 and 57, and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the Northern side of Cammer Avenue, joint Southern corner of Lots Nos. 15 and 16, and running thence along the dividing line of said lots N. 47-50 W. 166.5 feet to an iron pin, joint Northern corner of Lots Nos. 15 and 16; thence S. 42-07 W. 90 feet to a point; thence S. 47-50 W. 166.03 feet, more or less, to a point on Cammer Avenue 30 feet East of the joint Southern corner of Lots Nos. 17 and 18; thence with Cammer Avenue N. 42-10 E. 90 feet to the point of beginning.
