to it in hand duly paid at and before the sealing and delivery of these presents by the grantee (S.) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Perry G. Bridwell, his heirs and

assigns forever:-

All those certain pieces, parcels or lots of land situate, lying and being on the North side of Sycamore Drive near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lots No. 65 and 66 on plat of East Lynne made by Dalton & Neves, Engineers, June, 1931, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book H at page 195 and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the North side of Sycamore Drive at joint front corner of Lots 64 and 65 and running thence with the line of Lot 64, N. 9-14 W. 186 feet to an iron pin; thence along the rear line of Lots 43 and 44, S. 81-02 W. 50 feet to an iron pin; thence with the line of Lot 67, S. 9-14 E. 183.7 feet to an iron pin on the North side of Sycamore Drive; thence with the North side of Sycamore Drive, N. 83-46 E. 50.1 feet to the beginning corner.

This property is conveyed subject to the following building restrictions:

(1) The lot herein conveyed shall never be sold, rented, used or disposed of to negroes or persons of African descent.

(2) No residence shall be erected on said property costing less than \$1500.00.

(3) The building line as shown on the recorded plat above referred to and also all other restrictions shown on said plat are to be strictly adhered to.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinabove named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

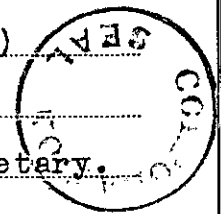
