All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

in City View, on the east side of Parker Avenue, having the following courses and distances:

Beginning at an iron pin on Parker Street, thence S. 12 3/4 E. 113 feet with Parker Street, to iron pin; thence N. 82 1/4 E. 160 feet to iron pin; thence N. 13 E. 92 1/2 feet to iron pin; thence S. 88 3/4 W. 206 feet to beginning, being lots 5 and 6 as shown on plat and survey by W. A. Hudson, March 8, 1904, less, however, the following described parcel or lot of land: All that piece, parcel or lot of land in City View on the east side of Parker Avenue, corner of other property of Casper P. West, running thence with Parker Avenue S. 12 3/4 E. 43 feet; thence in an easterly direction 160 feet, more or less, to iron pin; thence N. 13 E. 30 feet to iron pin; thence S. 88 3/4 W. 206 feet to beginning this 43-foot lot facing Parker Avenue (Street) having been sold to Ella Mae Sutton by Casper P. West on March 6, 1935, deed recorded in Book 180, page 35, R.M.C. Office for said County.

Also all that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, in the second ward of the City of Greenville, east of North Street, and on McGee Street, having the following courses and distances:

Beginning at a stake on the east side of McGee Street, and running thence N. 76 1/4 E. 169 feet to stake; thence N. 13 W. 70 feet to stake; thence S. 76 1/4 W. 171 feet to stake on McGee Street; thence with McGee Street S. 22 E. 71 feet to beginning.
