WHEREAS, the said Lois M. Wilson is desirous of obtaining a right of way for ingress and egress from Kenwood Drive across certain lot or lots of the said Kenneth B. Miles and Charlotte E. Miles to the rear portion of property owned by her.

NOW, THEREFORE, in consideration of the sum of One dollar and other consideration to us in hand paid by the said Lois M. Wilson, receipt where of is hereby acknowledged, we, the said Kenneth B. Miles and Charlotte E. Miles, do hereby grant, extend and convey to the said Lois M. Wilson, her heirs, executors, administrators and assigns an easement or right of way for the purpose of ingress and egress over and across either of lots Nos. 14, 16 or 22 of said Kenwood Subdivision, said lots being shown on a plat of said subdivision, which plat is of record in R. M. C. Office for Greenville County in Plat Book K, page 104, reference to which is hereby craved for a more complete description of said lots; said right of way or road to be constructed across only one of the above named lots, the particular lot of the three above named, across which said road or right of way shall extend, to be hereafter selected by the said Lois M. Wilson.

It is understood and agreed that said right of way, road or easement shall extend from the north side of Kenwood Drive across one of the three lots above named to property now owned by the said Lois M. Wilson and shall have a width not in excess of twenty feet.

Wilson which fronts on Summitt Drive should be sold, that the purchase or purchasers of said lots fronting on said Summitt Drive shall not have access to or the right to use the right of way hereby granted and that said right of way or easement hereby granted shall insure to and be limited to only two families who may at such time be occupying the rear portion of the said Wilson property, it being the intention hereby to limit the use of said driveway or easement to two homes to be hereinafter constructed at the rear of the Wilson property.
