All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

in the City of Greenville, Ward 1, and fronting on the South West side of Buncombe Street, having the following metes and bounds, to-wit:

Beginning at an iron pipe on the South West side of Buncombe Street, corner of the B.O. Woodward lot, running thence S. 56-30 W. eighty-seven-and-seven-tenths (87.7!) feet to an iron pin (line formerly 91.7 ft. but was reduced by widening south west side of Buncombe Street); thence S. 36-45 E. thirty-and-four-tenths (30.4!) feet to an iron pipe; thence S. 23-20 W. three (3!) feet to an iron pin; thence S. 22-55 W. one hundred and fifty-seven (157!) feet to an iron pin, formerly a fence post; thence S. 70-53 E. forty-and-five-tenths (40.5!) feet to an iron pin; thence N. 47-46 E. sixty-nine and seven-tenths (69.7) feet to an iron pin; thence N. 40-09 W. fifteen (15!) feet to an iron pin; thence N. 55-51 E. one hundred twenty-nine and seven-tenths (129.7!) feet to an iron pin on the property line of the South West side of Buncombe St.; thence N. 34-01 W. one hundred twenty-four and eight-tenths (124.8!) feet, to the point and place of the beginning.

It is the intention of the Grantors to convey to the Grantee herein all the real estate they now own within the said boundary, as acquired by deed to M. B. Bridges recorded in Vol. 148, at page 20, on which is situated a two story brick building; it being understood that this lot is owned by the Grantor, M. B. Bridges while the Eastern portion of the said boundary is owned jointly by the Grantors herein, and being the same lot conveyed to the Grantor, H. R. Stephenson by J. B. Earle, and one-half undivided interest therein was subsequently conveyed to M. B. Bridges, all of which said deeds are recorded in R. M. C. Office for Greenville County, and are hereby referred to for a more complete description, and as further shown by Plat prepared by Dalton and Neves for J. B. Earle, dated March 19, 1935, and plat prepared for W. A. Merritt by R. E. Dalton dated October 1923, which said plats are hereby referred to, and the description therein adopted by reference.
