Camp in the State afcresaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. H. Camp;

All that piece, parcel or lot of land in Greenville Township, Greenville County State of South Carolina, in the City of Greenville, and being situate on the South side of West Washington Street, and more particularly described as follows:

Beginning at a stake on the South side of said Street at the Northwest corner of the Lot conveyed by R. E. Houston to Elizabeth D. Zimmerman by deed dated July 5, 1944, and recorded in Deed Book 265, Page 249, R. M. C. Office for Greenville County; and running thence with the line of said Lot S.  $23\frac{1}{2}$  W. 217.5 feet to a stake at the Southwest corner of the Zimmerman Lot; thence N.  $66\frac{1}{2}$  W. 40 feet to a stake; thence N.  $23\frac{1}{2}$  E. 217.5 feet to a stake on the South side of said Street; thence S.  $66\frac{1}{2}$  E. 36 feet to the beginning. Subject however, to a joint or common driveway 8 feet in width, 4 feet of which is taken from a portion of the Eastern line of the Lot herein conveyed, and 4 feet of which is taken from a portion of the Western line of the Zimmerman Lot, and said driveway is duly referred to and set out in the deed to Zimmerman above mentioned.

The said Kate P. Houston subsequently died intestate leaving as her sold heirs at law and distributees, a son R. E. Houston, a daughter Norwood Houston Crews, a son W. H. Houston, a son L. B. Houston, a son Paul H. Houston and a grandson John H. Wearn, who was a son of Elizabeth Houston Wearn. The said Elizabeth Houston Wearn predeceased her mother Kate P. Houston. Paul H. Houston died testate August 11, 1942, devising all of his property to his widow Mary Good Houston, as will be shown by reference to Apartment 453, File 16., Probate Judge's office for Greenville County. W. H. Houston died testate October 18, 1943, and by his will devised his interest in the property conveyed above to the First National Bank of Greenville, S. C. in Trust, with power to sell and convey, and said Bank was also appointed Executor under said will. The grantor John H. Wearn is a widower.
