STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

AGREEMENT MADE AND ENTERED into this the 26th day of June, A. D. 1942, by and between Raymond Eugene Cannon and Louise Miller Cannon, sets forth:

THAT WHEREAS, the said parties are husband and wife, having been married in Greenville County, S. C. January 22nd, 1941, but have not lived together continuously and all the time since then, they having found living together very incompatible, and have concluded that they cannot peacefully and peaceably live together as man and wife, and have agreed to forever separate themselves from each other, now, therefore, it is agreed and covenanted;

That the said parties will from henceforth live separate and apart from each other; that neither will interfere with nor molest the other in his and/or her domestic, commercial, social, reliquous or other phase of life, her will either suffer or permit such to be done by outsiders so far as in her and/or his power to prevent, nor will either encourage or incite such to be done to or towards the other.

Each of the parties hereby releases the other from any obligations of any nature, by way of dower, support, maintenance, attention, care, alimony, allowance for living expenses or otherwise in any nature whatsoever, on account of the said marital relation and status heretofore existing between them; and the said Louise Miller Cannon expressly waives and renounces the right to any allowance or payment to her on account of the said Raymond Eugene Cannon being in the services of the armed forces of the United States, whether in times of peace or war.

Should any further or other documents of releases of any nature be desired on the part of either party hereafter, the other agrees to execute the same whenever and insofar as the same does not in any wise conflict with this agreement, or abridge any rights of either hereunder.

Any changes in or modifications of this agreement by the said parties to be entered in writing and signed by each of the parties hereto, and attached hereto as supplementary hereof.

This agreement to go into effect immediately upon its signing and delivery, and to continue of force during the life of either of the said parties hereto; and each hereby releases the estates of the other from any claims or demands of any nature whatsoever, and to such hereby binds the heirs, executors and administrators of each to the faithful performance hereof.
