Culbertson, his wife, all that certain lot, piece or parcel of land situate, lying and being in said state and county, a short distance north of the corporate limits of the City of Greenville, known and designates as Lot Number twelve (12) on G. A. Schulze's plat dated April 10, 1925, of a subdivision of Lots Numbered 7. 8. and 9 of Section "E" of Buist Circle, as shown on F. G. Rogers' plat recorded in the office of the Register of Mesne Conveyances for said county in Plat Book "C", page 10 (known also as Lot No. 12 on a revision of said Schulze plat made on July 21, 1941), and having, according to said Schulze plat and the revision thereof, the following metes and bounds, to-wit: Beginning at a stake on the south side of Buist Avenue, four hundred feet, more or less, westward from Townes Street Extension (said stake being on the northwest corner of Lot No. 10 of the Buist Circle plat), and running thence along Buist Avenue N. 80-15 W. sixty (60) feet to a stake on the northeast corner of Lot No. 11 of the Schulze plat; thence S. 9-45 W. 177.6 feet, more or less, along line of said Lot No. 11 to a stake on the north side of Ashley Avenue (formerly known as Wharton Avenue; thence along Ashley Avenue N. 81 E. for ty-six (46) feet to a stake at bend of street; thence (still along Ashley Avenue) due east 17.2 feet, more or less, to a stake on the southwest corner of Lot No. 10 on the Buist Circle plat; thence along line of said Lot No. 10 N. 9-45 E. 160.5 feet, more or less, to the beginning corner; this being the eastern part of the parcel of land conveyed to me by George A. Buist et al, by deed dated March 14, 1917, and recorded in said office in Book 36, page 189.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said grantees and their heirs and assigns forever. And I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said grantees and their heirs and assigns against myself and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
