Assigns forever:

All that certain piece, parcel or lot of land situate, lying and being on the East side of West Avondale Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, known as Lot No. 21 of Block G on revised plat of Northgate made by R. E. Dalton, Engineer, May, 1939, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book M, at page 13 (see also Plat Book G, pages 135 and 136) and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the East side of West Avondale Drive at joint front corner of Lots Nos. 20 and 21 of Block G and running thence with the line of Lot No. 20 in an Easterly direction 225.8 feet to an iron pin on the West side of an alley; thence with the West side of said alley in a Southerly direction 100 feet to an iron pin on an alley at the joint rear corner of Lots Nos. 21 and 22; thence with the line of Lot No. 22 in a Westerly direction 202 feet to the East side of West Avondale Drive; thence with the East side of West Avondale Drive in a Northerly direction 102.4 feet to the beginning corner.

This property is conveyed subject to the following restrictions and reservations:-

- (1) No building shall be erected nearer than 40 feet to West Avondale Drive.
- (2) No dwelling shall be erected on said Lot costing less than \$6,000.00.
- (3) This lot shall be used for residential purposes only, except this shall not apply as to Section D on the plat above mentioned.
- (4) The property shall not be sold, rented or otherwise disposed of to persons other than of the Caucasian race.
- (5) No obnoxious or offensive trade shall be carried on on the property.
- (6) No building of a temporary structure shall be erected on the property for use as a residence.
- (7) An easement is reserved along the rear line of the lot, two (2) feet in width, for the purpose of placing sewerage, telephone and electric lines or other utilities, with the right of entry for maintaining and repairing said utilities.
