

THIS CONTRACT OF MARRIAGE made and entered into at Greenville in the State of South Carolina, United States of America, this 20th day of June, 1945, by and between David Clephan Elliot of Khushab, District, Sargodah, Punjab, India, an Indian Civil Servant and Nancy Franelle Haskins of 901 Oak Street, Chattanooga, in the State of Tennessee, United States of America, Spinster, the daughter of Dr. John Bunyan Haskins,

WITNESSETH:

THAT WHEREAS heretofore a marriage was intended by the said parties to be had between them and each of the parties had engaged, promised and agreed with and to the other to make and consummate the said marriage, and

WHEREAS the said David Clephan Elliot, being a member of the Indian Civil Service, was sent to, and, because of the exceptional circumstances arising from the present war, has remained in India in the government service, so that the intended marriage could not and cannot be had and solemnized in the usual manner under the ordinary forms, and

WHEREAS there exists no legal impediment to the lawful marriage of the parties, and

WHEREAS, good and sufficient reasons them thereunto moving, the said parties desire to carry their said intention to intermarry into present and immediate effect;

NOW THEREFORE IN CONSIDERATION OF THE premises and of the mutual and reciprocal covenants and agreements herein and hereby under-taken and made:

(1) The said David Clephan Elliot, does hereby solemnly agree to take and takes the said Nancy Franelle Haskins as his true and lawful wedded wife to live together in the Holy State of Matrimony and does hereby acknowledge and declare that the said Nancy Franelle Haskins is now henceforth his wife, and he her husband.

(2) The said Nancy Franelle Haskins, does hereby solemnly agree to take and takes the said David Clephan Elliot as her wedded husband, to live together in the Holy State of Matrimony, and does hereby acknowledge and declare that the said David Clephan Elliot is now henceforth her husband and she his wife.

(3) The said David Clephan Elliot hereby constitutes and appoints the said Nancy Franelle Haskins his attorney in fact, with power of substitution, for the purpose of making, doing or obtaining or causing to be made done or obtained any and all things acts licenses publications records or assurances necessary, required or permitted by the laws of any state or territory of the United States or the District of Columbia for the further better and absolute effecting and assurance of the said marriage.

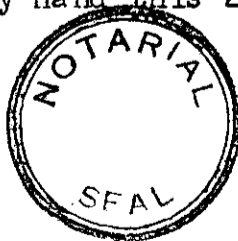
