in consideration of the sum of Nine Hundred Forty-five and No/100- - - - - (\$945.00)----DOLLARS,

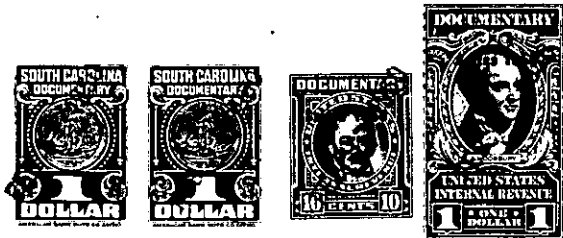
