in consideration of the sum of Seven Hundred and No/100 (\$700.00)----- DOLLARS,

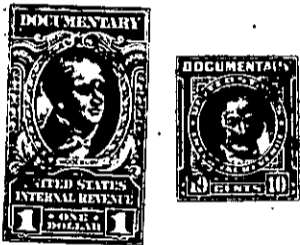
