

All those certain pieces, parcels or lots of land situate, lying and being on the West side of the Davidson Road in Paris Mountain Township, Greenville County, S. C., being shown as Lots 6, 7 and 8 on Plat of Property of Dit White Poe made by J. C. Hill, Surveyor, May 1947, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of the Davidson Road at joint front corner of Lots 5 and 6 and running thence along the line of Lot 5 N. 64-30 W. 837.1 feet to an iron pin: thence N. 36-15 E. 667.4 feet to an iron pin; thence S. 53-0 E. 709.2 feet to a stake in the center of Davidson Road; thence along the Davidson Road S. 41-45 W. 185.2 feet to an iron pin on the West Bank of Davidson Road; thence S. 12-30 W. 275 feet to a point in Davidson Road; thence continuing with Davidson Road S. 19-45 W. 69.3 feet to the beginning corner.

This is a portion of that property conveyed to me by deed of W. P. Earp, dated March 22, 1946, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 289, page 343.

ALSO, all that certain piece, parcel or strip of land in Paris Mountain Township, Greenville County, South Carolina, being shown as the Northeast part of Lot 6, on the plat of property of Lee P. Ramsey made by J. C. Hill, Surveyor, May 3, 1948, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book S, at page 117, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the intersection of two county roads, joint corner of Lots 6 and 8 on said Plat, and running thence S. 26-15 E. 227 feet to an iron pin in line of property of Dit White Poe; thence with said Poe line S. 37-15 W. 22.6 feet to an iron pin in the rear line of Lot 6; thence thru Lot 6 M. 26-15 W. 255.1 feet to an iron pin in center of county road; thence with center of said county road S. 65-30 E. 26.7 feet to the beginning corner.

This is the same property conveyed to me by deed of H.F.A. Lange dated January 27, 1950.
