Crain and Edna Mae W. Crain and their heirs and assigns:

All of that parcel or tract of land in Highland Township of Greenville County, South Carolina, lying on the East side of a road leading from Pleasant Hill to Oneal (The Old Greenville Road), having the following courses and distances: BEGINNING on a stake in branch, and runs thence S. 81.30 W. 1163 feet to a point in the center of said road; thence with said road N. 12.45 W. 421 feet to a point in said road, W.C.Johnson and J.W. Barbare corner; thence with Johnson's line N. 80.20 E. 430 feet to a stone; thence N. 76.50 E. 638 feet to a stake in the branch; thence down the meanders of said branch S. 29.56 E. 298 feet to a bend; thence S. 14.10 E. 195 feet to the beginning corner, containing 11.20 acres, more or less, adjoined by other lands of grantees and by lands of W.C. or Mrs. W.C. Johnson and others.

On April 2, 1949, the grantor sold the above lands to W.C. Johnson. (See deed on record in the R.M.C. Office for Greenville County in Deed Book 378, at page 307). In preparing deed to W.C. Johnson, the grantor's name was inadvertantly inserted in the granting clause, the habendum clause and the warranty clause, when the name of W.C. Johnson should have so inserted. This deed is made for the purpose of correcting said error and for the purpose of quit-claiming all right, title and interest in the above lands to the present owners, the grantees herein.
