

BEGINNING at a point on the East side of said Maco Terrace, at the joint corner of Lots Nos. 4 and 5, and running thence with the said Maco Terrace J. 36-05 E. 55 feet to a point, joint corner of lots Nos. 5 and 6; thence with the joint line of said lots Nos. 5 and 6, N. 54-03 E. 125 feet to a point, joint rear corner of lots Nos. 5 and 6; thence N. 36-05 W. 55 feet to a point, joint rear corner of lots Nos. 4 and 5; thence along the joint line of said lots Nos. 4 and 5, S. 54-03 W. 125 feet to the beginning point, joint corner of lots Mos. 4 and 5 on the east side of said Maco Street.
