

Know All Men by These Presents:

I, W. Louis Williams

in consideration of the sum of Four Thousand Two Hundred and No/100- - - - - (\$4,200.00) - DOLLARS, and assumption of mortgage set out below,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James D. Williams, his Heirs and Assigns forever,

All that lot of land in Greenville County, State of South Carolina, in the City of Greenville, on the Eastern side of Highland Drive, being known and designated as Lot No. 7 of Block B as shown on Plat of East Highland Estates, recorded in Plat Book K at Pages 35 and 36, and being more particularly described according to a recent survey of J. C. Hill dated November 18, 1947 as follows:

BEGINNING at an iron pin on the Eastern side of Highland Drive, which pin is 475.4 feet South of the intersection of Highland Drive and the Laurens Road, and is the joint front corner of Lots Nos. 6 and 7 of Block B, and running thence with the joint line of said lots, S. 79-05 E. 310 feet to a stake in the Western side of a five-foot easement; thence along the line of said easement, S. 7-11 W. 55 feet to a stake at the joint rear corner of Lots Nos. 7 and 8; thence with the joint line of said lots, N. 84-11 W. 287 feet to an iron pin on the Eastern side of dighland Drive, at the intersection of Carolina Avenue; thence with the curve of Highland Drive, the chord of which is N. 8-00 W., 85 feet to the point of beginning.

Said premises being the same conveyed to the Grantor by J. Dan Williams, Jr. by deed recorded in Book of Deeds 323 at Page 347.

As a part of the consideration for this deed, the Grantee assumes and agrees to pay a balance of \$4,750.00 due on a mortgage executed by the Grantor to Fidelity Federal Savings & Loan Association in the original amount of \$5500.00, dated November 5, 1947, recorded in Book of Mortgages 372 at Page 184.
