

SEVEN LOTS:

BEGINNING at an iron pin at the Northwest intersection of Gibbs Street and Mayfield Street, and running thence along the North side of Gibbs Street, N. 57-29 W. 120.75 feet to an iron pin; thence N. 30-11 E. 97.5 fect to an iron pin: thence N. 58-04 W. 51.7 feet to an iron pin; thence N. 22-06 E. 247.7 feet to an iron pin at the corner of property now or formerly of Rufus Yearsin; thense with the line of said Yearsin property, S. 56-38 E. 133.3 fest to an iron pin on the West side of Mayfield Street: thence with the West side of said Stre t as the line. S. 18-0 W. 348 feet to point of beginning.
