(1) Said lots shall be used exclusively for residential purposes only.

(2) No dwelling shall be erected on said lots nearer than 100 feet to the front

line of said lot.

(3) No dwelling shall be erected on either of said lots to cost less than \$10,000. but this shall not apply to servant's quarters to be erected on rear portion of said lots.

Said lots shall not be subdivided so as to construct more than one dwelling on the front of each lot to have a frontage of 100 feet each.
