M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

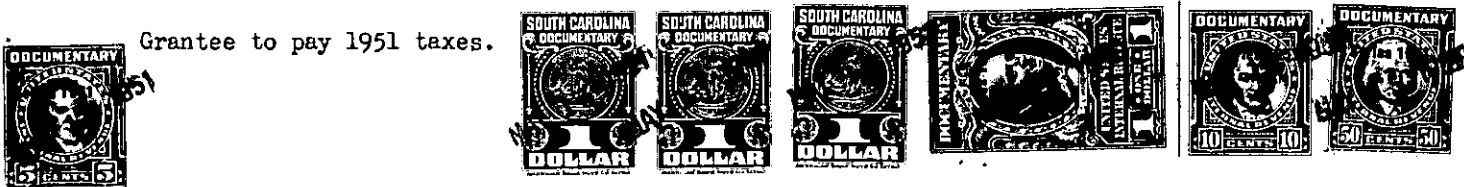
BEGINNING at an iron pin at the Northwestern intersection of Beverly Lane and Bradley Boulevard and running thence with the Western side of Beverly Lane N37-34W 182.5 feet to an iron pin, rear corner of Lot No. 116; thence with rear line of Lot No. 116 S52-26W 75 feet to an iron pin, joint rear corner Lot Nos. 98 and 99; thence with joint line of said lots S37-34E 182.5 feet to an iron pin on Northern side of Bradley Boulevard; thence with Bradley Boulevard N52-26E 75 feet to the beginning corner and being lot No. 98.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
