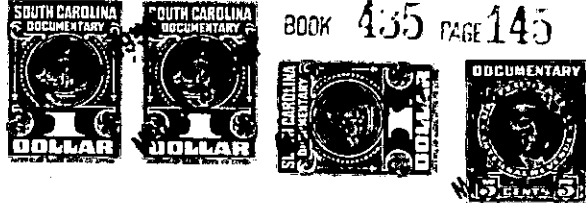

in the State aforesaid, DOLLARS,

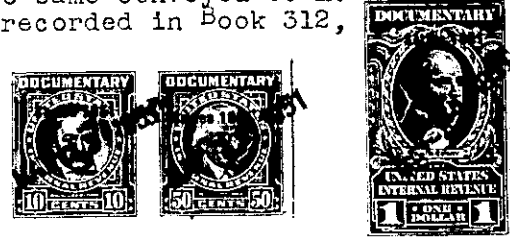
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said L. P. Floyd and Sallie C. Floyd

All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, on the south side of Arch Street Extension, and being known and designated as Lot No. 24 and the eastern half of Lot No. 23 on a plat of the property of F. B. Massingale made by J. Coke Smith & Sons, Surveyors, May 15, 1947, and recorded in the R. M. C. Office for Greenville County in Plat Book W, page 109, and having the following metes and bounds according to said plat:

BEGINNING at a stake on the south side of Arch Street Extension at corner of Lot No. 25, and running thence in a southwesterly direction with Arch Street Extension 90 feet to stake; thence in a southeasterly direction 229.85 feet to stake; thence N. 60-24 E. 90 feet to stake at corner of Lot No. 25; and thence with line of Lot No. 25 in a northwesterly direction 228.8 feet to the beginning corner.

The above described lot of land is a portion of the same conveyed to me by E. Inman, Master, by deed dated May 20th, 1947, and recorded in Book 312, page 234.

The grantees agree to pay taxes for the year 1951.
