KNOW ALL MEN BY THESE PRESENTS. That We, E. C. Hindman, Jr., Grace Hindman, Henry L. Hindman, Marion F. Hindman, Hilda H. Carver, F. E. Carver, Marion F. Hindman as Trustee for Lucy Lee Hindman, and Henry L. Hindman as Trustee for Lucy Lee Hindman, herein called grantors in the State aforesaid, in consideration of the sum of One Dollar and recitals above

given Dollars

to us in hand paid at and before the sealing of these presents by Elizabeth L. Marchant, herein called grantee,

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee

all that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, which are shown as Tracts Nos. 4 and 5 as shown on plat of property of Lucy L. Hindman, Butler Township, made in October, 1939, by W. J. Riddle, which plat has been recorded in Plat Book 24 at Page 18-19, and at Page 50-51, and from this plat the following description is taken:

BEGINNING on the southern side of a road at the joint corner of Tracts 3 and 4, and running thence the joint line between these tracts S. 21-15 E. 200' to a corner; thence S. 05-30 W. 130' to a corner in line of Tract 2; thence running the joint line between Tracts 4 and 9, N. 28-45 W. to the joint corner of Tracts 4, 5, and 9, a distance of 75' more or less; thence along the line between Tracts 5 and 9, S. 57-45 W. 155' to a corner; thence along the line between Tracts 5 and 6, N. 28-45 W. 253' to a corner in the road first named; thence along the center of this road N. 05-30 E. passing the joint corner between Tracts 4 and 5 to a corner, a distance of 172' more or less; thence continuing along the center of the road S. 03-30 E. to the beginning corner, a distance of 175' more or less.
