

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the North side of Arthur Avenue, near the City of Greenville, S. C., being known and designated as Lot No. 18, Block L, on plat of O. P. Mills property, recorded in Plat Book C, at page 176, R. M. C. Office for Greenville County, and having according to a survey and plat thereof by Pickell & Pickell, Engineers, January 23, 1945, the following metes and bounds, courses and distances, to-wit:

BEGINNING At an iron pin on the North side of Arthur Avenue at the corner of Lot No. 19 and running thence with the line of that lot, N. 44-33 W. 180 feet to an iron pin; thence N. 45-27 E. 60 feet to an iron pin, corner of Lot No. 17; thence with the line of that lot, S. 44-33 E. 180 feet to an iron pin on the North side of Arthur Avenue; thence with said Avenue, S. 45-27 W. 60 feet to the beginning corner.
