To All Whom These Presents Shall Come:

I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Lettie P. Campbell, and Broadus Campbell, Individually, and Broadus Campbell and I. M. Owings as Surviving Executors of the Will of W. F. Campbell, deceased, et al.

on or about the 21st day of April in the year of our Lord nineteen hundred and fifty-one exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against Anna Belle Campbell, Individually and as Administratrix of the Estate of Wm. Carl Campbell, deceased, et al.

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 28th day of July 1951, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for the County aforesaid, to Cleo C. Owings for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. F 3141)

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Cleo C. Owings, her heirs and assigns forever:-

That certain lot of land, with any improvements thereon, School District No. 285, Chick Springs Township, said County and State, known as lots Nos 22 and 23 on plat of the N. M. Cannon property, made by H. S. Brockman, Jan. 16th, 1924, and recorded in R.M.C. office, having the following courses and distances, to-wit:-
Beginning at the N.W. corner of Buncombe Street and Green Street, and runs thence with Green Street, S 13- E one hundred fifty (150) feet to corner of lot #42; thence S 81-15 W one hundred (100) feet to corner of lot #21; thence dividing Nos. 21 and 22 lots, N 13 W one hundred fifty (150) feet to edge of Buncombe Street; thence therewith N 81-15 E one hundred (100) feet to the beginning corner, and being the same conveyed to W. F. Campbell by deed of W. W. Pollard recorded in Vol. 171 page 209.

Also, that certain lot of land with any improvements thereon in or near the City of Greer, School District #285, Chick Springs Township, said County and State, and having following courses and distances, to-wit:-
Beginning on James Street, corner lot #7, and runs thence N 11-17 E one hundred eighty and one-tenth (180.1) feet to corner of lot #1; thence N 62-25 W fifty-seven and five-tenths (57.5) feet to corner of lot #9;
