C., on the south western side of the intersection of the Greer-O'Neal Highway and a surface treated road which connects S. C. Highways #14 and #415 (the latter road will hereafter be referred to only as "surface treated road" in the below description), the same being shown and designated as lots #2 and #3 on Plat No. 2 of the property of the "L. W. Jones Estate", plat made by H. S. Brockman, surveyor, dated May 24, 1951, and recorded in Plat Book "T", at Page 362, R. I. C. Office for Greenville County, and having, according to said plat, the following courses and distances, to wit:

BEGINNING at a nail in the center of the intersection of the Greer-O'Neal Highway and said "surface treated road" and running thence along said "surface treated road" S 88-45 W 291 feet to a point in the center of said road; thence S 2-46 E 195 feet to a P.O. Stump; thence S 36-40 E 462.8 feet to a stake; thence S 77-15 W 191.5 feet to a stake across a branch; thence S 37-50 E 222 feet to a point, joint corner of lots 3 and 4 on said plat; thence N 42-30 E 505 feet to a point in the center of the Greer-O'Neal Highway; thence up said Greer-O'Neal Highway N 34 W 500 feet to the beginning corner.

According to said plat lot #2 contains 2.41 acres,
