

KNOW ALL MEN BY THESE PRESENTS, That I, Roy A. Bowen,

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said. Liberty Life Insurance Company, its successors and assigns, forever:

All that lot of land with the improvements thereon situate, lying and being on the Southeast side of Super Highway U. S. No. 29 (also known as the Greenville-Spartanburg Highway) and on the East side of S. C. Highway No. 291 (sometimes referred to as the By-Pass leading from the Super Highway U. S. No. 29 to the Laurens Road), near the City of Greenville, in Butler Township, Greenville County, State of South Carolina, and having, according to a survey made by Dalton & Neves, Engineers, October 1951, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast edge of the right-of-way of Super Highway U. S. No. 29, said point being where the Southeast edge of said right-of-way intersects with the East edge of the right-of-way of S. C. Highway No. 291, and running thence along the East edge of the right-of-way of S. C. Highway No. 291, S 1-44 W 191.95 feet to an iron pin; thence N 89-07 E 308.8 feet to an iron pin; thence along the line of property this day conveyed by A. B. Green to Liberty Life Insurance Company, the Grantee herein, N 2-41 W 180.1 feet to an iron pin; thence continuing with the line of said Green property, N 46-37 W 210.3 feet to an iron pin on the Southeast edge of the right-of-way of Super Highway U. S. No. 29; thence along the Southeast edge of said right-of-way, S 43-06 W 197.5 feet to an iron pin; thence continuing with said right-of-way, N 46-54 W 9.7 feet to the beginning corner.

ALSO, all my right, title and interest in and to that strip of land embraced within the boundaries of the right-of-way of Super Highway U. S. No. 29, lying Southeast of the center line of said right-of-way of said highway, and lying Northwest of and adjacent to the entire highway frontgage of the property above described; and

ALSO, all my right, title and interest in and to that strip of land embraced within the boundaries of the right-of-way of S. C. Highway No. 291, lying East of the center line of said right-of-way of said high-way, and lying west of and adjacent to the entire highway frontgage of the property above described.

This property was conveyed to the Grantor by deed of A. B. Green, dated November 26, 1940, recorded in Deed Book 228, at page 106, and by deed of T. E. Green, dated June 6, 1929, recorded in Deed Book 148, at page 119, said R. M. C. Office.
