All that piece, parcel, or lot of land, with the improvements thereon, situate, lying and being in the Green Mill Village, in or near the City of Greer, Greenville County, South Carolina, and being more particularly described as Lot .107, as July n on a plat entitled "Subdivision of Greer Mill Village, Greer, S. C.," made by Dalton and Neves, January 1951, and recorded to the R. M. C. Office for Greenville County in Plat Book Y at pages 138 and 139. According to said plat, the within described lot is also known as No. 2 8 ... Galliyan Street (Avenue) and fronts thereon ____69 __feet.

The grantor and its predecessors in title have granted unto City of Greer, S. C., Southern Railway Company, Pickment, and Northern Railway Company, Southern Bell Telephone and Telegraph Company, and Duke Power Company, to one or more of them and or to others all water and sewer pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sewer lines) valves, fittings hydrants, manholes, poles, wires, transformers, regulators and other apparatus and equipment used in connection with: or forming a part of, the water, for protection, electric light and power distribution, and sewerage systems of the village known as Green Mill Village in which the above described lot is located, together with rights of way and easements to go upon the land for the purpose of maintenance, repair, alteration, replacement, construction, relocation, and expertation (including meter reading) of the lines and systems aforesaid and of certain other water, sewer, electric, telephone, railway, and power lines constructed or to be constructed, and to relocate certain of such lines so as to run them in, along, above or near the streets and alleyways located in Green Mill Village and to operate and maintain the lines as so relocated, all as will more fully appear by reference to the records in the R.
