to it in hand duly paid at and before the scaling and delivery of these presents by the grantee(s) hereinafter named, (the receipt who reof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

LESLIE L. RUDISAIL AND CARRIE S. RUDISAIL

All that piece, parcel, or lot of land, with the improvements thereon, situate, lying and being in the Greer Mill Village, in or near the City of Greer, Greenville County, South Carolina, and being more particularly described as Lot 126. as shown on a plat entitled "Subdivision of Greer Mill Village, Greer, S. C.," made by Dalton and Neves, January 1951, and recorded in the R. M. C. Office for Greenville County in Plat Book Y at pages 138 and 139. According to said plat, the within described lot is also known as No. 21 Geer Street (Avenue) and fronts thereon 88 feet.

The grantor and its predecessors in title have granted unto City of Greer, S. C., Southern Railway Company, Piedmont and Northern Railway Company, Southern Bell Telephone and Telegraph Company, and Duke Power Company, to one or more of them and/or to others all water and sever pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sever lines) valves, fittings, hydrauts, manholes, poles, wires, transformers, regulators and other apparatus and equipment used in connection with, or forming a part of, the water, fire protection, electric light and power distribution, and sewerage systems of the village known as Greer Mill Village in which the above described lot is located, together with rights of way and easements to go upon the land for the purpose of maintenance, repair, alteration, replacement, construction, relocation, and operation tincluding meter reading) of the lines and systems aforesaid and of certain other water, sower, electric, telephone, railway, and power lines, ponstructed or to be constructed, and to relocate certain of such lines so as to run them in, along, above or near the streets and allegways located in Greer Mill Village and to operate and to relocate certain of such lines and specified of the results of the results. South Caroline, and for and to rejocate certain of such lines so as to run them in, along, above or near the streets and alleyways located in Greer Mill Village and to operate and maintain the lines as so relocated, all as will more fully appear by reference to the records in the R. There is excepted and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described, and this conveyance is made subject to the rights of way and easements above mentioned insofar as they may affect said lot.

This conveyance is made subject to the following restrictions:

(1) That no mercantile establishment, other than those already in existence, shall be erected operated or maintained on the lot above described.

(2) That only one residence shall be creeted or maintained on any one lot.

(3) That no livestock, except fowl, may be kept, stabled or penned thereon or brought to the premises. Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, and his (her or their) Heirs and Assigns forever.

And the said J. P. Stevens & Co., Inc., does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his (her or their) heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
