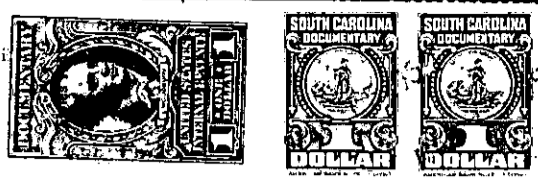

William L. Campbell and June M. Campbell, their heirs and assigns forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, Lot number 134 Augusta Acres, as per plat recorded in Flat Book S at page 201, in Greenville County Courthouse, South Carolina and having been prepared by Dalton and Neves, 1946 and being situate on the East side of Patton Drive, having a frontage of 130 feet, more fully described as follows:

BEGINNING at an iron pin on the East side of Patton Drive, joint corner of Lots No. 133 and 134, and running thence with line of lot No. 133 and rear line of Lot No. 156, N. 72-06 E. 400 feet to an iron pin, joint corner of Lots No. 134, 145, 146, 155 and 156; thence with rear line of lot No. 145, S. 8-03 W. 156.8 feet to an iron pin, joint corner of Lots No. 134 and 135; thence with line of Lot No. 135, S. 72-06 W. 337 feet to an iron pin on the East side of Patton Drive; thence with Patton Drive, N. 17-54 W. 130 feet to an iron pin, the beginning corner. This property is conveyed subject to recorded rights-of-way.

Said property is conveyed subject to the following restrictions and conditions: Said property is to be used for residential purposes only, and no residence is to be erected on said property costing less than \$5,000.00; no residence to be less than 30 feet from Patton Drive; this property is not to be sold, rented or otherwise disposed of to any person of African descent; the stream on said property is not to be diverted from where it enters upon lot No. 145.
