All that certain piece, parcel or lot of land situate, lying and being on the West side of Davidson Road in Paris Mountain Township, Greenville County, South Carolina, being shown as Lot No. 5 on plat of property of Dit White Poe made by J. C. Hill, Surveyor, May 1947, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a nail in cap in the center of Davidson Road at joint front corner of Lots 4 and 5, said point being 814.2 feet North from the corner of property now or formerly of J. L. Dawson, running thence along the line of lot No. 4, N. 66-30 W. 901.8 feet to an iron pin; thence N. 36-15 E. 219.1 feet to an iron pin at rear corner of Lots 5 and 6; thence with the line of lot No. 6 S. 64-30 E. 837.1 feet to a nail in cap in the center of Davidson Road; thence along the center of Davidson Road, S. 19-45 W. 185 feet to the point of beginning.
