to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Guerry W. Green, his heirs and assigns forever:

All that piece, parcel or lot of land in the City of Greenville, S. C., situate and being on the North side of De Oyley Avenue, and being known and designated as Lot No. 219 of Augusta Road Ranches, as shown on a plat thereof by Dalton & Neves, dated April, 1941, revised April, 1942, and recorded in Plat Book M, page 47, and having according to said plat the following courses and distances, to-wit:
