Know All Men by These Presents:

That We, W. H. McMakin and M. A. Hudson, in the State aforesaid, in consideration of the sum of Ten (\$10.00) - - - and other valuable consideration, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said D. G. Wilson and J. C. Wilson, their heirs and assigns, forever:

All that certain piece, parcel or lot of land with all the buildings and improvements thereon, situate, lying and being on the North side of the South Saluda River, in Cleveland Township, Greenville County, South Carolina, being known and designated as Lot 9 as shown on plat made by J. B. Chastain, Surveyor, July 1949, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "V", at page 195, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point 15 feet South of the City of Greenville Water Pipe line paralleling the North bank of the South Saluda River, which point is the Northern corner of Lots 8 and 9; thence along the line of Lot 8, S. 60 E. 1.95 chains to a stone xm on the North bank of South Saluda River; thence along the North bank of South Saluda River in a Northeasterly direction 66 feet to a stone xm at joint rear corner of Lots 9 and 10; thence along line of lot 10, N. 60 W. 1.73 chains more or less to a stone xm at joint northern corner of Lots 9 and 10; thence S. 88-30 W. 66 feet to the point of beginning and containing one-fifth (1/5) of an acre, more or less.

This property is sold subject to the following restrictions:

(1) It is distinctly understood that this property is sold subject to a 25 foot roadway which is to be cut along the pipe line for the common use of all property owners.

(2) This property is to be used for residential purposes only and no trade or business can be carried on that will create or constitute a nuisance.
