in consideration of the sum of Two Thousand and Forty-nine and 50/100 DOLLARS,

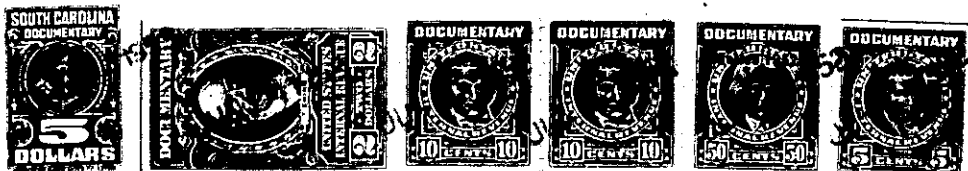
