If Lessee shall exercise the above option to renew this Lease, it shall do so by written notice to Lessors no less than (C days prior to the expiration of the original term of this Lease.

It is understood and agreed that in the event the Lessee shall exercise the option herein granted to renew this Lease, all the other terms, covenants, conditions and agreed its level centified which were effective during the original term hereof shall remain in full force and effect during such renewal term.

Lessors also hereby mant unto Lesson the Orling cytion: VI-B. The first right and option to renew this Issue a on the termination of the first renewal option hereinabove and out in Sec. VI-A. If the parties cannot agree on the terms of escol, then Lessee shall have the first right and option to enter into a new lease of the derised premises upon the terms and conditions contrined in any bona fide offer made to Lessors by any responsible third marty desiring to lease said premises for the use aforestic thick Lessons shall desire to accept. The terms and conditions contained in any such offer and the name and address of the turty making the offer shall be communicated by Lessons to Lessee in uniting and Lessee shall have until thirty (30) days ofter receipt of some in which to accent or reject a lease on such terms and conditions. If Lossee shall exercise said option, it shall do so by notice in writing to Lessors in the manner hereinafter provided for notice.

It is understood and agreed that in the event of the exercise by Lessee of the aforegoing option, all the towns, provisions and conditions of this Lease not specifically covered in the

aforegoing offer shall be and remain the same as provided in this Lease.

It is further understood and agreed that the provisions of this Paragraph VI-B shall survive the termination of this Lease for a period of one (1) year; expressly subject, however, to the aforesaid thirty (30) day acceptance period.
