

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt when of is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Eunice Anderson, her heirs and assigns, forever:

All that lot of land situate on the South side of Pack Alley, in the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 14 on plat of Queen Heights, made by N. O. McDowell, Jr. and J. P. Moore, November 1944, recorded in the R. M. C. office for Greenville County, S. C. in Plat Book "O", Page 87, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Pack Alley at joint front corner of Lots 13 and 14, and running thence along the line of Lot 13, S. 21-45 W. 112.5 feet to an iron pin; thence N. 68-43 W. 40 feet to an iron pin; thence with the line of Lot 15, N. 21-45 E. 112 feet to an iron pin on the South side of Pack Alley; thence along the South side of Pack Alley, S. 69-48 E. 40 feet to the beginning corner.
