CHARTER 4
BY THE SECRETARY OF STATE

WHEREAS, THOMAS E. WORLEY, Box 1942, Greenville, S. C. and
J. A. BAYNE, Box 1942, Greenville, S. C.

did on the 16th; day of June 1952, do hereby certify that they have signed by themselves, setting forth:

FIRST: That their names and residences are as above given

SECOND: That the name of the proposed corporation is BAYNE WORLEY COIN OPERATORS

THIRD: That the principal place of business is 200 Lexington Avenue
Box 1942
GREENVILLE, S. C.

FOURTH: That the general nature of the business which the proposed corporation to own and operate coin operated amusement machines, including the leasing and selling of the same, and other operations necessary to the proper conduct of such business.

FIFTH: That the amount of the capital stock is Five Thousand (\$5,000.00) - - - - - Dollars payable paid in full.

SIXTH: That the number of shares into which the capital stock is divided Fifty (50) of the par value of One Hundred (\$100.00) - - - - - Dollars

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 12th. day of June, 1952, at which a majority of all stock in value being present in person or by proxy, the following were elected directors:

EIGHTH: That subsequently there was elected as President, Thomas E. Worley ;
as Vice-President, J. A. Bayne ; as Secretary, Thomas E. Worley ;
as Treasurer, J. A. Bayne

NINTH: That all requirements of Article 2, Chapter 153, Code of Laws of South Carolina, 1942, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Piedmont

a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
