Thompson, his heirs and assigns**, all that piece, parcel or lot of land, situate, lying and being on the Northerly side of Arlington Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 25, Block E, Paris Heights, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book Y, page 65, and having, according to said plat, the following metes and bounds, to wit:
