

All that lot of land situate on the Southwest side of Beechwood Avenue, in the City of Greenville, in Greenville County, State of South Carolina, shown as Lots 9, 10 and 11 on plat of the Davis property, made by R. K. Campbell, and J. L. Hunter, Surveyors, July 1951, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "AA", Page 123, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwest side of Beechwood Avenue at joint front corner of Lots 8 and 9 and running thence with the line of Lots 8 and 12, S. 54-39 W. 150 feet to an iron pin; thence along the line of property of B. L. Boland, N. 28-0 W. 210 feet to an iron pin on the South side of Haviland Avenue; thence along the South side of Haviland Avenue, N. 58-20 E. 136.4 feet to an iron pin at the corner of the intersection of Haviland Avenue and Beechwood Avenue; thence along the Southwest side of Beechwood Avenue, S. 23-08 E. 67.3 feet to an iron pin; thence following the curve of Beechwood Avenue (the chord being S. 29-23 E. 67.3 feet) to an iron pin; thence continuing with the curve of Beechwood Avenue (the chord being S. 42-21 E. 67.3 feet) to the beginning corner.
