ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile southwest from Greer, S. C., lying on the eastern side of a new road that leads by Matt's fishing pond or lake, being bounded on the northern side by a lot being conveyed this day by the grantor herein to Willie a. Oliver, on the eastern side by lands of I. M. Wood Estate, on the southern side by another lot being conveyed this day by the grantor herein to Ruth B.
