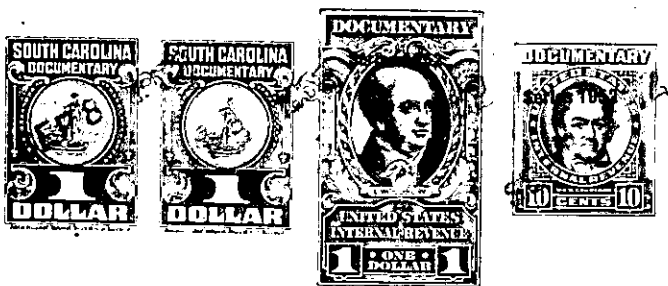

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ~~Estadido Boney~~ J. A. Cannon, Jr.,

all that piece, parcel or lot of land in Paris Mountain Township, Greenville

County, State of South Carolina, on Woodland Drive, in the Sub-Division of the Central Life Insurance Company of the Tindal land about three miles north of the City of Greenville, said lot being a part of lot seventeen (17) as sub-divided by James R. Rodgers and shown on Plat to be recorded in the Office of the Register of Mesne Conveyance for Greenville County, and being known and designated as lot numbered one (1), and having the following lines, courses and distances:-

Beginning at an iron pin on Woodland Drive, said pin being the joint front corner of lots one (1) and two (2); and running thence along said Woodland Drive, N. 18-43 E., seventy-five (75) feet to an iron pin, joint front corner of lots one (1) and sixteen (16); thence along the southern line of lot sixteen (16), S. 71-17 E., two hundred and ten (210) feet, to an iron pin, rear corner of lot one (1); thence along the rear line of lot three (3), S. 18-43 W., seventy-five (75) feet, to an iron pin, joint rear corner of lots one (1) and two (2); thence along the northern line of lot two (2), N. 71-17 W., two hundred and ten (210) feet, to an iron pin, the beginning corner.
