Highway No. 276, and being known and designated as lot No. 10, as shown on plat of Nannie K. Hunt Estate, recorded in Plat Book AA at Page 134, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin in the Western side of U. S. Highway No. 276, at front corner of lot 9, and running thence with line of said lot, S. 63-30 W. 255 feet to iron pin in line of lot 30; thence with line of said lot, S. 26-15 E. 100 feet to an iron win, corner of lot 11; thence with line of said lot, 2. 63-30 E. 250 feet to an iron pin in the Western side of U.
