

All that lot of land in Greenville County, Gantt Township, State of South Carolina, known and designated as Lot No. 26, according to plat of property of Woodfields, Inc., a subdivision located on the southwest side of the Augusta Road, said lot having the following metes and bounds as shown on plat made by Dalton & Neves, Engineers, March, 1947, recorded in R. M. C. Office for Greenville County in Plat Book S, page 7:

BEGINNING at an iron pin on Glennwood Lane, joint front corner of Lot 25, and running thence along line of Lot 25, N. 50-22 E. 130.6 feet to an iron pin; thence N. 2-12 E. 130.5 feet to iron pin, joint rear corner of Lot No. 30; thence along line of Lot #30 S. 75-57 W. 60 feet to iron pin, joint rear corner of Lot 27; thence along line of Lot 27, S. 33-12 W. 181.2 feet to iron pin on Glennwood Lane; thence along Glennwood Lane S. 47-23 E. 70 feet to beginning corner.

As a part of the consideration, the grantee herein assumes and agrees to pay the balance due upon the following notes and mortgages:

(1) Note and mortgage executed by Woodfields, Inc. to the Peoples National Bank of Greenville, S. C. in the original amount of \$7,600.00, which mortgage is recorded in the R. M. C. Office for Greenville County in Mortgage Book 389 at page 242 and on which there is a balance of \$6,708.42.

(2) Note and mortgage executed by the grantor herein unto the Peoples National

Bank of Greenville, S. C. dated July 20, 1948 in the original amount of \$2,000.00, which mortgage is recorded in the R. M. C. Office for Greenville County in Mortgage Book 395 at page 273 on which there is a balance due of \$1,584.50. The property hereby conveyed is subject to restrictive covenants of record in

the R. M. C. Office for Greenville County in Deed Book 319 at Page 350.
