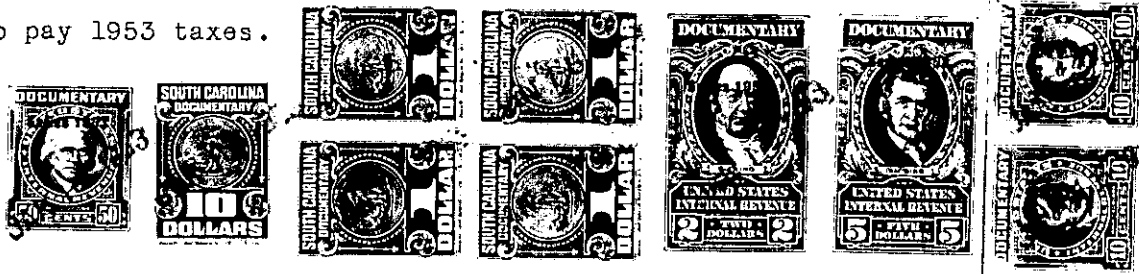
E. M. Bishop, his heirs and assigns, forever:

BEGINNING AT an iron pin on the east side of the Augusta road, at corner of lot heretofore conveyed by John B. Scoggins, to L. J. Carrere and running thence along the Carrere line, N. 87-17 E. 100 feet to an iron pin; thence N. 87-17 W. 110 feet to an iron pin; thence S. 87-17 W. 100 feet to an iron pin on the East side of the Augusta Road; thence along the east side of the Augusta Road, S. 87-17 E. 110 feet to the beginning corner.
