to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. E. Meadors,

All that certain piece, parcel or lot of land situate, lying and being in Butler Township, Greenville County, state of South Carolina, being known and designated as lot No. 17 on plat of property of Aziloe G. Boyd, known as Glenwood Acres, recorded in the R. M. C. Office for Greenville County in Plat Book AA at page 183 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southeast side of Dubard Street, the joint corner of lots Nos. 16 & 17, and running thence with the joint line of said lots S. 25-24 E. 170 feet to an iron pin corner of lot No. 13; thence with the rear line of lot No. 13 N. 64-36 E. 90 feet to an iron pin corner of lot No. 18; thence with the line of said lot N. 25-24 W. 170 feet to an iron pin on the southeast side of Dubard Street; thence with the southeast side of said street S. 64-36 W. 90 feet to the beginning corner.

This being one of the lots conveyed to the grantor by Aziloe G. Boyd by deed dated November 24, 1952 recorded in deed volume 467 page 392 of the R. M. C. Office for Greenville County.
