That I, Romaine Barnes

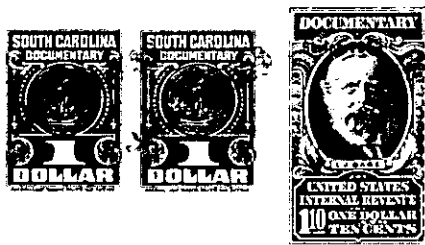
in consideration of the sum of \$10.00 and other considerations in the State aforesaid, DOLLARS,
