Leo Sherman -- his heirs and assigns all that piece, parcel or Lot of land in Gantt Township County of Greenville, State of South Carolina and having the following metes and bounds: Beginning at an Iron pin on Smith Street at the corner of Delia Dillard's Lot and running S-57-43 E 208.5 to an Iron pin at the joint corners of Moses Dillard thence S-34-00W 206 feet to an Iron pin thence N. 56-35 W. 210 Feet to an Iron pin on Smith Street thence N 34-00 E 210 feet along Smith Street to the point of beginning.
