benefit, and as my act and deed, to do and execute, or to concur with persons

of the following acts, deeds, and things, that is to say:

- 1. To buy, receive, lease, accept, or otherwise acquire; to sell, convey, mortgage, hypothecate, pledge, quit-claim or otherwise encumber or dispose of; or to contract or agree for the acquisition, disposal, or encumbrance of; any real or personal property whatscever or any custody, possession, interest or right which I may have therein, upon such terms as my said attorney shall think proper.
- 2. To take, hold, possess, invest, lease, or let, or otherwise manage any or all of my property or any interest therein; to eject, remove or relieve tenants or other persons from, and recover possession of, such property by all lawful means; and to maintain, protect, preserve, insure, remove, store, transport, repair, rebuild, modify or improve the same or any part thereof.
- 3. To buy, sell, exchange, lease or rent, register, re-register, mortgage, encumber, berrow money upon, take out licenses in respect of, insure, collect insurance upon, and otherwise deal with any automobile or automobiles or any other personal or real property in which I may have any interest, right, or property, or of which I may be the record owner,
- 4. To make, do, and transact all and every kind of business of any nature or kind whatsoever, including the receipt, recovery, collection, payment, compromise, settlement, and adjustment of all accounts, legacies, bequests, interests, dividends, annuities, demands, debts, taxes, and obligations, which may now or hereafter be due, owing, or payable by me or to me.
- 5. To make, indorse, accept, receive, sign, seal, execute, acknowledge, and to deliver deeds, assignments, agreements, certificates, hypothecations, checks, notes, bonds, vouchers, receipts, and any other instruments in writing of whatever kind or nature.
- 6. To deposit, withdraw, and cash, for any purpose, in or from any bank, building and loan association, trust company or any other financial institution, including U. S. Postal Savings, any funds, checks, negotiable paper, or other credits, which may come into my said attorney's hands, or which I now or hereafter may have on deposit or be entitled to, and to endorse, cash, and receive the proceeds of any or all checks, vouchers, or other orders for money; to have access for all purposes to any or all safety deposit boxes or vaults rented in my name or in the names of any other person or persons and myself, with full power to use the same for safe-keeping any securities, valuables, or other property and to remove therefrom at any time or from time to time all or any part of the contents of any such box or vault; and to act as my attorney or proxy in respect to any stocks, shares, bonds, or other instruments, rights, or interests which I may now or hereafter hold.

To make, execute and file income and other tax returns and declarations of estimated tax required to be made by me by any law, either Federal or State, for the taxable year 1950 and for each subsequent year; to represent and act for me in all tax matters in dispute or intigation, in any governmental department or court; to receive, endorse, and collect checks in settlement of any refund of taxes for such years; to file claims for abatement, refund or credit of taxes; to make any adjustments or settlements and to sign any and all receipts, waivers, settlements or agreements, with reference to or pertaining to, income taxes and other taxes duly assessed by law.
