That I, James W. Hicks, of Greenville County, in the State aforesaid, in consideration of the sum of Six Hundred Forty Nine (\$649.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Marvin H. Sloan, his heirs and assigns,

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, about five miles south of Greenville Court House, east of and near Augusta Road, being shown and designated as Lot Number Twenty Three (No. 23), on southern side of Eastview Drive on plat of survey of subdivision known as "Clearview Heights" by M.H.Woodward, R.E., Dec. 1945, recorded in Plat Book "P" at page 1 in R.M.C. office for said County, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at iron pin on southern side of Eastview Drive, joint front corner with Lot No. 22 of said plat, and running thence S. 18-04 E. 267.6 feet to iron pin on northern side of Clearview Drive, joint rear corner with said Lot No. 22; thence S. 75-33 W. 86.4 feet along northern side of Clearview Drive to iron pin, joint rear corner with Lot No. 24; thence N. 18-04 W. 261.9 feet along line of Lot No. 24 to iron pin on southern side of Eastview Drive, joint front corner with Lot No. 24; thence N. 71-56 E. 86.2 feet along southern side of Eastview Drive to the point of beginning.

The above described property is part of a tract of 18.91 acres, more or less, conveyed to me by Willis and others by deed dated Nov. 3, 1944, recorded in Vol. 269 at page 179 in said R. M. C. office.

This property is conveyed, however, subject to the protective covenants as set forth and recorded in Vol. 396 at page 141 in said R. M. C. office.

Also, subject to right of way reserved for sidewalk and power line across front of said lot.
