

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the eastern side of Dargan Avenue, being known and designated as Lot No. 16 of the property of Talmar Cordell and James H. Campbell, according to a plat thereof prepared by C. C. Jones, Eng. in October 1950, revised and replatted by Dalton & Neves, March 1951, and recorded in the RMC Office for Greenville County in Plat Book "Z" at page 175, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Dargan Avenue at the joint front corner of Lots No. 16 & 17, which pin is 345 feet from the southeast corner of the intersection of Dargan Avenue with Florida Avenue Extension, and running thence along the joint line between Lots No. 16 & 17, N. 75-47 E. 180 feet to an iron pin at the rear corner of said lots; thence S. 14-13 E. 80 feet to an iron pin at the joint rear corner of Lots No. 15 & 16; thence along the joint line between Lots No. 15 & 16, S. 75-47 W. 180 feet to an iron pin at the joint front corner of said lots on the eastern side of Dargan Avenue; thence along the eastern side of Dargan Avenue, N. 14-13 W. 80 feet to the beginning, being the same property conveyed to the grantor by W. R. Cordell by deed dated November 7, 1951, and recorded in the RMC Office for Greenville County in Deed Book 445 at page 381.

As part of the consideration stated above, the grantees assume and agree to pay the balance due upon a mortgage executed by the grantor to the First Federal Savings & Loan Assn. of Greenville in the original amount of \$7,700.00, dated Nov. 7, 1951 and recorded in the RMC Office for Greenville County in Mortgage Book 514 at page 494, said balance due being \$7,392.38.
