All that lot of land with the buildings and improvements thereon, situate on the Southwest side of Augusta Road in the City of Greenville, Greenville County South Carolina and having according to a plat made by Dalton & Neves, Engineers, April 1936, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Augusta Road at corner of lot now or formerly of L. M. Ashmore, and running thence with the Southwest side of Augusta Road S. 56-30 E. 104 feet to an iron pin at corner of property now or formerly of Mrs. D. W. Cochrane; thence with the Cochrane line S. 35-15 W. 220 feet to an iron pin; thence along line of other property of the grantor, R. B. Gresham, N. 56-30 W. 104 feet to an iron pin in line of the L. M. Ashmore lot; thence along the line of the Ashmore property N. 35-15 E. 220 ft. to an iron pin on Southwest side of Augusta Road the beginning corner.
